

## **Official Rules for the Tom Holland VIP Experience Contest**

*A promotion to benefit The Brothers Trust*

**Agreement to Official Rules.** Participation in the “Tom Holland VIP Experience Contest” (the “**Contest**”) constitutes Eligible Entrant's full and unconditional agreement to and acceptance of these Official Rules and the decisions of The Brothers Trust Events Team (“**Sponsor**”), which are final and binding in all aspects of this Contest. The Contest is subject to all applicable federal, state, provincial, and local laws and regulations. Void where prohibited.

**Odds.** The odds of winning the Contest will depend on the number of eligible entries received and the Contest winners will be selected based on skills, not at random.

**Eligibility.** The Contest is open only to the following individuals (each, an “**Eligible Entrant**”):

1. Individual legal residents of, and physically located within, the United States (excluding the States of Arizona, Hawaii, Idaho, Iowa, Louisiana, Montana, Nevada, or Washington); Canada; the United Kingdom; the European Union (excluding Italy); Australia; or another country that is NOT listed as a “Prohibited Jurisdiction” as follows: Afghanistan, Bahamas, Belgium, Belize, Bolivia, Cambodia, Chad, China, Colombia, Crimea, Cuba, Dominican Republic, Ecuador, Egypt, El Salvador, Ghana, Guatemala, Guinea, Haiti, Honduras, Iran, Iraq, Italy, Jamaica, Lebanon, Mali, Myanmar, Nicaragua, North Korea, Pakistan, Panama, Peru, Singapore, Somalia, Sudan, Syria, Tanzania (the United Republic of), Thailand, Trinidad and Tobago, Tunisia, Turkey, Uganda, Ukraine, Venezuela, Yemen, Zimbabwe, any country under sanction or embargo restrictions by the United States, and any other country where local laws would prohibit the provision of or entry into this Contest; and
2. United States and United Kingdom individuals who are at least 13 years of age or older, or for Canada, 16 years of age or older, or for other countries, at least the age of majority or older as of the date of entry; and
3. If a minor under the laws of their country or state of residence, have parent or guardian permission to enter the Contest under the terms of these Official Rules.

Any entry submitted by any ineligible person(s) will be void.

The Contest is void where prohibited or restricted by law. All the directors, officers, employees and agents of Sponsor, The Brothers Trust (“**Charity**”), RallyUp.com, Inc. (“**Administrator**”), Columbia TriStar Marketing Group, Inc. (“**CTMG**”), and each of their respective subsidiaries, affiliates, sales representatives, distributors, licensees, agents, website administrators, advertising and Contest agencies, and any immediate family members (spouses, parents, children, and siblings and their respective spouses, regardless of where they reside) and those living in the same household (whether related or not) of any of the foregoing, are not eligible to participate in the Contest.

**Contest Period.** The Contest will consist of three (3) non-live contests (each, a “**Pre-Event Contest**”) and one (1) livestream event (the “**Livestream Event**”). Each Pre-Event Contest will consist of three (3) phases as set forth in the tables below (all times Eastern Standard Time (“**EST**”). Eligible Entrants that try to register before or after the applicable Submission Phase for the Pre-Event Contest will be disqualified. Registration for the Livestream Event will start on November 12, 2021, at 12:01 am EST and end on November 27, 2021, at 3:30 pm EST (the “**Livestream Period**”). Eligible Entrants that try to register before or after the Livestream Period will be disqualified. The Administrator’s computer system shall be the official timekeeper for the Contest.

#### Pre-Event Contest Details.

**A. Submission Phase.** To enter the Pre-Event Contests (i.e., "Ask Tom" Contest, "Caption It" Contest, and the "Name Tom's Future Dog" Contest) portion of this Contest, during the applicable Submission Phase set forth above, Eligible Entrant must (i) access <https://brotherstrust.livli.com/tom-nwh/Sale> (the "**Website**"); (ii) complete and submit the applicable Contest entry form by filling in all required information, including Eligible Entrant's [name, country of residence, email address, phone number], (iii) submit Eligible Entrant's answer to the applicable Contest question (each, a "**Submission**"), and (iv) make a donation of \$5.00 to Charity with an eligible debit or credit card. Only Submissions submitted in compliance with these Official Rules will be accepted. Plagiarized Submissions will result in disqualification. Each Submission must be entrant's own original work, and may not be offensive or inappropriate, as determined by the Sponsor in its sole discretion, nor can the Submission defame or invade publicity rights or the privacy of any person living or deceased, or otherwise infringe upon any person's personal or property rights or any other third-party rights, including, without limitation, patent, trademark, copyright or other intellectual property rights. Sponsor reserves the right to disqualify any entry it deems to be offensive, inappropriate, or not in keeping with Sponsor's image, in its sole discretion. A Submission will not be accepted if it includes any third-party patented designs or inventions, trademarks, trade dress, logos, copyrighted material or any other intellectual property of any individual, company, or other entity that the organization does not have the right to use or which may imply a false association or sponsorship or violate the intellectual property rights of others. Each Eligible Entrant acknowledges that any breach or violation of these Official Rules, or a third-party asserting rights to any Submission, shall immediately disqualify the entrant during any phase of the Contest. Sponsor is not responsible for any entries that are lost, late, misdirected, incorrect, garbled, or incompletely received, for any reason, including by reason of hardware, software, browser or network failure, malfunction, congestion, or incompatibility at Sponsor's servers or elsewhere, which entries are void. If all required information is not included, entry will be disqualified.

**B. Pre-Screening of all Submissions.** By completing the applicable Contest entry form and submitting the Submission, each Eligible Entrant agrees that each Submission conforms to these Official Rules and that Sponsor, in its sole discretion, may remove any Submission and disqualify entrant from the Contest if it believes that any Submission fails to conform to these Official Rules. If entrant's Submission is rejected, entrant may have another opportunity to upload a new Submission until the earlier of its acceptance by Sponsor or the end of the applicable Submission Phase.

**C. Voting Phase.** During the applicable Voting Phase of each Pre-Event Contest, a committee comprised of up to ten (10) Administrator employees and/or agents (the "**Voting Committee**") shall select, in its absolute and sole discretion, the top fifty (50) Finalist entries for each Pre-Event Contest from amongst the eligible Finalists for each Pre-Event Contest based on the following criteria: creativity and originality of Submission – 50% and overall quality of submission – 50%. By entering the Contest, each entrant agrees that the Voting Committee's decisions regarding the winners and in regard to all matters relating to each Pre-Event Contest (including, without limitation, regarding eligibility) shall be final and binding in all aspects.

**D. Judging Phase.** During the applicable Judging Phase of each Pre-Event Contest, a committee comprised of up to five (5) Sponsor employees and/or agents (the "**Judging Committee**") shall select, in its absolute and sole discretion, the Grand Prize winner for each Pre-Event Contest from amongst the eligible Finalists for each Pre-Event Contest based on the following criteria: creativity and originality of Submission - 50% and overall quality of Submission – 50%. By entering the Contest, each entrant agrees that the Judging Committee's decisions regarding the winners and in regard to all matters relating to each Pre-Event Contest (including, without limitation, regarding eligibility) shall be final and binding in all aspects.

**E. License/Use Rights.** Each Eligible Entrant hereby grants an irrevocable, perpetual, royalty free, worldwide, and non-exclusive license to Contest entries, including Submissions, and any copyrighted or copyrightable works or other intellectual property therein to Sponsor to copy, distribute, modify, and create derivative works of the copyrighted or copyrightable works or other intellectual property to Sponsor. Further, Eligible Entrant expressly agrees and acknowledges that the license granted to Sponsor is freely assignable to others by Sponsor without notice to Eligible Entrant. By entering the Contest, the Eligible Entrant agrees that the Sponsor shall have the right, but not the obligation, to edit, remove, modify, publish, sublicense, print, transmit, display, or otherwise use any submitted Contest entry, including Submissions, via all forms of media now known or hereafter devised worldwide, in perpetuity, without notice, attribution or compensation to Eligible Entrant, his/her successors or assigns, or any other entity, except where prohibited by law. Eligible Entrant waives any retained rights of attribution, privacy, publicity, withdrawal, integrity, or other moral or personal rights in the entry and other related materials, including any Photos. All entries and other submitted materials will not be returned to any Eligible Entrant. If Sponsor requests the Eligible Entrant's cooperation in promoting the Contest, the Eligible Entrant agrees to reasonably be available for such promotional activities.

**F. Winner Notification.** Potential Grand Prize winners of each Pre-Event Contest will be announced during the Livestream Event which occurs from 3:00 pm EST to 3:45 pm EST on November 27, 2021. Winners do not need to attend the Livestream Event to win. Each potential Grand Prize winner for each Pre-Event Contest will be notified by email and/or by telephone following the Livestream Event and may be required to execute and return an affidavit of eligibility/liability release and, where lawful, a publicity release (collectively, the "**Affidavit/Release**") within three (3) days of date of issuance. Each Eligible Entrant is fully responsible for any and all applicable federal, provincial, state, and local taxes. Each Eligible Entrant that is a United States resident (each, a "**US Eligible Entrant**") understands that the Sponsor or its respective agents may advise the United States Internal Revenue Service of the value of the Prize (as defined below) awarded to such US Eligible Entrant from such US Eligible Entrant's participation in the Contest in the form of an IRS Form 1099, or otherwise. Each US Eligible Entrant understands that prior to being entitled to receive any prize, and prior to receiving any prize, such US Eligible Entrant may be required to first provide Sponsor with all of such US Eligible Entrant's applicable taxpayer identification information and other required and reasonably requested tax and tax-related documentation (e.g., IRS Form W-9). If any potential winner declines in writing to accept a prize, such required information or documents are not returned within the specified time period, prize or prize notification is returned as undeliverable, the Sponsor is unable to contact a potential winner within seventy two (72) hours, or a potential winner is not otherwise in compliance with these Official Rules, the prize will be forfeited and, at the Sponsor's sole discretion and time permitting, Sponsor may select as the replacement winner the first runner-up winner based on the Committee's determination.

**G. Grand Prize.** Each Grand Prize winner of the corresponding Pre-Event Contest will each receive a grand prize as follows (each, a "**Pre-Event Contest Grand Prize**"):

**H. Runner-Up Prizes.** Four Runner-Up winners of the "Ask Tom" Pre-Event Contest will each receive a runner-up prize as follows: one (1) Spider-Man Hot Toys Figure signed by Tom Holland, each, a "**Pre-Event Contest Runner-Up Prize**". Two Runner-Up winners of the "Caption It" Pre-Event Content, will each receive a runner-up prize as follows: one (1) Brothers Trust Jigsaw Puzzle. Two Runner-Up winners of the "Name Tom's Future Dog" Pre-Event Content, will each receive a runner-up prize as follows: one (1) Brothers Trust Jigsaw Puzzle.

### **Livestream Event Details.**

**A. How To Enter.** To participate in the Livestream Event portion of the Contest, during the Livestream Period, Eligible Entrant must (i) purchase a \$15.00 Livestream Registration from November 12, 2021 at 12:01 am EST until November 27, 2021 at 3:30 pm EST with an eligible debit or credit card through the <https://brotherstrust.livli.com/tom-nwh> website ; (ii) access <https://brotherstrust.livli.com/tom-nwh/Event> Livestream Event; (iii) compete in the Livestream Event Contest by writing in the correct answer(s) in the chat bar ; (iv) provide all required information, including Eligible Entrant's name, country of residence, email address, and phone number, through the Website. The Livestream Event will consist of a Movie Pictionary game ("**Movie Pictionary Contest**" with four (4) rounds that can be viewed on the Website where all Eligible Entrants that have properly registered for the Livestream Event during the Livestream Period will compete against each other Eligible Entrant to correctly name the movie or a fact about the movie that is being hand drawn by the hosts on a drawing pad. The Livestream Event hosts will draw out movie poster on a drawing pad to the Eligible Entrants (each, a "**Question**") and the Eligible Entrants will be able to enter their answer(s) in the chat bar. The winners of the first three (3) rounds will be qualified to participate in the final round. If an Eligible Entrant wins more than once, they will not be given a competitive advantage in the final round. A correct answer to the Drawing Contest will provide the Eligible Entrant with access to the final round of the Drawing Contest. After the third Drawing Contest of the Livestream Event, the Eligible Entrants will compete in the final round. During the fourth round, the first Eligible Entrant to correctly answer the Drawing Contest will win the Grand Prize for the Livestream Event. The Administrator's computer system shall be the official timekeeper to determine the order of answers submitted in the chat bar for all Eligible Entrants.

**B. Winner Verification.** The potential Grand Prize winner of the Livestream Event will be announced during the Livestream Event. The potential Grand Prize winner of the Livestream Event will be notified by email and/or by telephone] following the Livestream Event and will be required to execute and return an Affidavit/Release within twenty four (24) hours of issuance. Each Eligible Entrant is fully responsible for any and all applicable federal, provincial, state, and local taxes. If any potential winner declines in writing to accept a prize, such required information or documents are not returned within the specified time period, prize or prize notification is returned as undeliverable, the Sponsor is unable to contact a potential winner within twenty four (24) hours, or a potential winner is not otherwise in compliance with these Official Rules, the prize will be forfeited and, at the Sponsor's sole discretion and time permitting, Sponsor may select as the replacement winner the first runner-up winner based on the Administrator's determination.

**C. Livestream Grand Prize.** The Grand Prize Winner of the Livestream Event will receive one (1) trip for the Livestream Grand Prize winner and one (1) guest to attend the United States premiere of "Spider-Man: No Way Home" in Los Angeles, California, on December 13, 2021, subject to change, in the sole and absolute discretion (the "**Premiere Event**"). Travel Dates: December 12, 2021 – December 14, 2021. The

Livestream Grand Prize consists of roundtrip coach air transportation for two (2) from a major gateway airport nearest Grand Prize winner's residence (as determined by Sponsor in its sole discretion); standard, double-occupancy hotel accommodations for two (2) nights at The London Hotel in the Los Angeles area; two (2) tickets to the Premiere Event ; ground transportation to/from hotel and the Premiere Event; two (2) tickets to attend a meet-and-greet/photo opportunity with actor Tom Holland at the Premiere Event; and \$1,000 in spending money (awarded in the form of a Visa Gift Certificate) (collectively, the "**Livestream Grand Prize**"). **ARV of the Livestream Grand Prize: \$4,450.** The actual retail value of the Livestream Grand Prize may vary, depending on the Livestream Grand Prize winner's place of residence. Any difference between the stated value and actual value of the Livestream Grand Prize will not be awarded to the Livestream Grand Prize winner. Selection of airport, airline, hotel, and ground transportation are solely within Sponsor's discretion. If in the judgment of Sponsor air travel is not required due to Grand Prize winner's proximity to Los Angeles, California, ground transportation will be substituted for roundtrip air travel at Sponsor's sole discretion. The Livestream Grand Prize winner (or, if a minor, such winner's parent or guardian) will be required to provide a credit card to the hotel to cover incidentals which are not included in the Livestream Grand Prize package. All travel, hotel, ground transportation and prize-related events are subject to availability and restrictions. The Livestream Grand Prize winner and travel guest must travel on same itinerary. If the Livestream Grand Prize winner is a minor, the Livestream Grand Prize winner's travel guest must be the minor's parent or legal guardian. If the Grand Prize winner is an adult, a minor of 13 years of age or older may accompany the adult Grand Prize winner as the travel guest only if the adult Grand Prize winner is the minor's parent or legal guardian. All minors must be accompanied at all times during trip (including, but not limited to, in-flight and during the hotel stay and all prize-related events) by minor's parent or legal guardian. Both Livestream Grand Prize winner and travelling companion (unless minor child of Grand Prize winner) must execute an Affidavit/Release prior to issuance of travel documents. The Livestream Grand Prize winner and travel guest must have all necessary identification and/or travel documents (e.g., a valid U.S. state issued driver's license or passport) required for travel. Livestream Grand Prize winner and guest are required to show proof of being fully vaccinated against COVID-19 at least two weeks prior to December 13, 2021, a negative PCR test for COVID-19 within seventy two (72) hours of the Premiere Event, and must wear a suitable protective face mask while inside the Premiere Event theater unless eating or drinking, subject to any government or industry restrictions and requirements due to the on-going COVID-19 global pandemic. Grand Prize winner and guest shall comply with any and all health and safety protocols and rules in effect from the local authorities and any additional requirements provided to Grand Prize winner by CTMG in CTMG's sole discretion in connection with the Premiere Event. The Livestream Grand Prize winner understands that there are inherent risks involved in travel and that these risks may be present before, during and after receipt and use of the Livestream Grand Prize. Sponsor reserves the right to change or cancel the meet-and-greet with Tom Holland portion of the Livestream Grand Prize if talent becomes unavailable due to any unforeseen circumstances. The opportunity to meet with Tom Holland is contingent upon the celebrity appearing for the event/activity. Sponsor is not responsible if the winner and/or guest is not able to meet with the celebrity due to cancellation, illness, conflict, act of God, or any other reason outside of the control of Sponsor. Sponsor is not responsible for changes in schedule, of any element of the Grand Prize, or for any expenses incurred as a consequence of flight cancellation or delay. Sponsor is not responsible and will have no liability if the Livestream Grand Prize winner and/or his/her travel guest are for any reason not permitted to travel by the relevant airport authorities or misses a flight or other Livestream Grand Prize element. It is recommended that the Grand Prize winner and his/her travel guest obtain sufficient personal insurance prior to departure. All costs and expenses associated with prize acceptance and use not specified herein are the sole responsibility of the applicable winner. Prizes are non-transferable and non-assignable and will be provided only to the winning Eligible Entrant. There will be no substitutions for any prize (or element thereof) except by the Sponsor who reserves the right to substitute a prize (or element thereof) with one of comparable or greater value at its sole discretion. No interest will be paid on any cash portion of the Livestream Grand Prize. Other restrictions may apply. Prize winners are responsible for paying all federal, state and local taxes on any winnings.

**Conditions/Use Rights.** By accepting any prize, each Eligible Entrant consents to the use of their names and all accompanying personally identifiable information Eligible Entrant submits, via all forms of media now known or hereafter devised worldwide, in perpetuity, without notice, attribution or compensation (other than the specific prizes described herein) to Eligible Entrant, his/her/its successors or assigns, or any other entity, except where prohibited by law.

**Privacy.** By participating in the Contest, each Eligible Entrant authorizes the Sponsor to collect, use, process, transfer, and store all data provided by Eligible Entrant, including without limitation, personal data, to the United States, or any location(s) throughout the world that the Sponsor deems necessary, whether within Eligible Entrant's country of residence or elsewhere, and with such party(ies) as the Sponsor deems appropriate, for purposes of administration of the Contest. All information submitted to the Sponsor as part of this Contest will be treated in accordance with the Sponsor's privacy policy, available at <https://rallyup.com/privacy-policy/>. Sponsor will only use Eligible Entrant's personal information to: (a) provide information about the Contest; (b) contact and publicize potential winners; and/or (c) if an Eligible Entrant selects to receive additional information from the Sponsor, to send additional information to that Eligible Entrant during or after the Contest Period. Eligible Entrants to the Contest may be given the option to receive commercial e-mails from the Sponsor; however, eligibility to participate in the Contest is not dependent upon Eligible Entrant's consent to receive such e-mails. Eligible Entrants must fully complete and submit all non-optional data the Sponsor requests to be eligible.

**Release and Limitations on Liability.** By participating in the Contest, each Eligible Entrant agrees, to the extent permitted by law, to release and hold harmless Sponsor, Charity, Administrator, CTMG, and each of their respective subsidiaries, affiliates, sales representatives, distributors, licensees, agents, advertising, and Contest agencies, and all directors, officers and employees of any of the foregoing entities (collectively, the "**Released Parties**"), from and against any claims, costs, injuries, losses and damages of any kind (including, without limitation, reasonable attorneys' and investigation fees, expert and consultant fees, and other litigation costs) (collectively, "**Losses**") arising out of or in connection with the Contest, whether under a theory of contract, tort (including negligence), warranty or other theory, including: (a) unauthorized human intervention in the Contest; (b) technical errors related to computers, servers, providers, or telephone or network lines; (c) printing errors; (d) lost, late, misdirected, incorrect, garbled, or incompletely received entries; (e) errors in the administration of the Contest or the processing of entries; (f) injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from Eligible Entrant's participation in the Contest or acceptance, receipt, use, or misuse of any prize (including personal injuries, death, or damage to or destruction of property), or travel to any Contest-related events (including if any Prize cannot be awarded due to travel cancellations, delays or interruptions due to acts of God, acts of war, natural disasters, weather or acts of terrorism); and (g) any claims based on publicity rights, copyright/trademark infringement, intellectual property rights, rights of publicity or privacy, or defamation or portrayal in a false light, whether intentional or unintentional. In the event that Eligible Entrant breaches any of these Official Rules, Released Parties shall be entitled to and may seek indemnification, to the extent permitted by law, from Eligible Entrant for recovery of all Losses that may be incurred by Released Parties as a result of the aforementioned breach. Each Eligible Entrant has agreed to the foregoing release freely and without any inducement or assurance of any nature, and intend it be a complete and unconditional release of all liability to the greatest extent allowed by law, and agree that if any portion of such release is held to be invalid, the balance notwithstanding shall continue in full force and effect. Each Eligible Entrant acknowledges the language of Section 1542 of the California Civil Code ("**Section 1542**"), which provides:

A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS THAT THE CREDITOR OR RELEASING PARTY DOES NOT KNOW OR SUSPECT TO EXIST IN HIS OR HER FAVOR AT THE TIME OF EXECUTING THE RELEASE AND THAT, IF KNOWN BY HIM OR HER WOULD HAVE MATERIALLY AFFECTED HIS OR HER SETTLEMENT WITH THE DEBTOR OR RELEASED PARTY.

Each Eligible Entrant hereby expressly waives the protection of Section 1542, or similar protections under any other law. Each Eligible Entrant understands and agrees that the released claims or facts in addition to or different from those which are now known or believed by such Eligible Entrant to exist may hereafter be discovered. It is each Eligible Entrant's intention to waive fully and release all of the claims that such Eligible Entrant now have against the Released Parties, whether known or unknown, suspected or unsuspected, except as to the released claims that cannot lawfully be released.

**Miscellaneous.** The decisions of Sponsor are final with respect to all aspects of this Contest. The Contest and these Official Rules will be governed, construed and interpreted under the laws of the State of Arizona, without regard to choice of law principles. Except where prohibited, each Eligible Entrant agrees that: (1) any and all disputes, claims, and causes of action arising out of or connected with this Contest or any prize

awarded shall be resolved individually, without resort to any form of class action, and exclusively by the applicable state or federal courts situated in Arizona; (2) any and all claims, judgments, and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Contest, but in no event attorneys' fees; and (3) under no circumstances will Eligible Entrant be permitted to obtain awards for punitive, incidental, special, consequential, or other damages, including without limitation, lost profits.
